Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of declaration, declaring that the entire Land Acquisition Proceedings initiated under section 4(1) Notification under Land Acquisition Act, 1894 in G.O.Ms.No.447, Housing and Urban Development L.A.1(2) dated 21.10.1999 and Section 6 Declaration in G.O.(Ms) No.494, Housing & Urban Development Department [L.A.(1)] dated 06.12.2000 under the Land Acquisition Act 1894 shall be deemed to have been lapsed by virtue of Section 24(2) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 i.e. The Central Act 30 of 2013 in respect of the petitioners' property situated S.Nos. 721/2A, 721/2B, 721/4, 722/1A1, 722/1A2, 723/2B, 724/2, 724/3, 727/1A1A, 727/1A1B & 727/1A2 to an extent of 0.01.0, 0.08.0, 0.06.0, 0.00.5, 0.34.5, 0.50.0, 0.36.0, 0.10.5, 0.31.5, 0.31.5 and 0.26.5 hectares in Kuthumbakkam Villae, Ponnammallee Taluk, Thriuvallur District.
