This Criminal Original Petition has been filed to extend the time granted by this Court in Crl.O.P.No.8915 of 2020, dated 18.06.2020, by another two weeks.

2 The learned counsel appearing for the petitioner would submit that though the order was granted by this Court in Crl.O.P.No.8915 of 2020, dated 18.06.2020, with a direction to the petitioner to surrender before the learned Magistrate Court within a period of two weeks, the order was uploaded in the web only on 04.07.2020 and the petitioner has surrendered before the learned Magistrate on 04.07.2020.
