3. Recording the said submission made by the learned Special Government Pleader appearing for CBI, this contempt petition is closed.

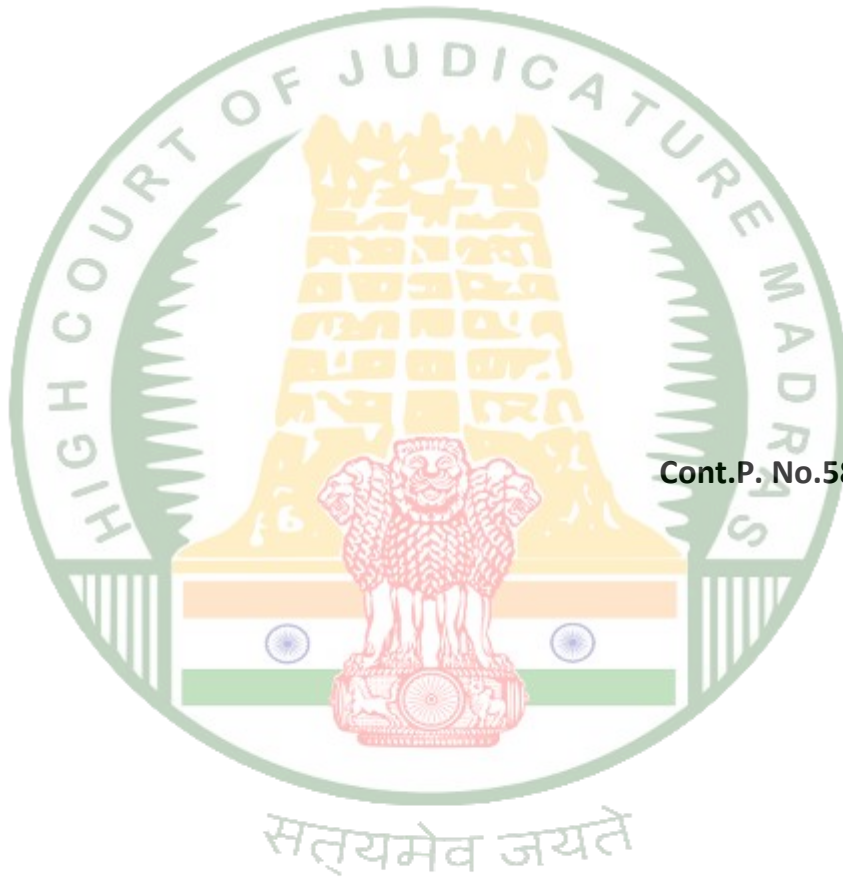
