2.The Learned counsel for the petitioners submitted that the petitioners have complied with a deposit of sum of Rs.5,000/- (Rupees five thousand only) to the Cancer Institute Adayar, Chennai and due to the lockdown the petitioners were unable to appear before the lower Court.
