O R D E R

The petitioner, who apprehend arrest at the hands of the respondent police for the offences publishable under sections 494, 506(ii) of I.P.C. in Crime No.not known of 2020, on the file of the respondent police, seeks anticipatory bail.

2. The learned Additional Public Prosecutor would submit that the petition enquiry against the petitioner is pending in CSR.No.249 of 2020 on the complaint of one Vaidooriyam.

3. The respondent police has to issue notice under Section 41(A) of Cr.P.C to the petitioner. The petitioner is directed to appear before the respondent police and the Investigating Officer has to conduct the enquiry by strictly following the procedures therein. The Investigating Officer is to either register a First Information Report or close the complaint by 30.08.2020. If the Investigating Officer has grounds to arrest the petitioner then he has to state the

reasons in writing and communicate the same to the petitioner and in that case, the petitioner is at liberty to file necessary application before this Court seeking Anticipatory Bail.

4. With this observation, this Criminal Original Petition is closed.
