Though the alleged encroachers, who are not made as parties before us, taking into consideration of the fact that no action has been taken pursuant to the communication of the first respondent to the second respondent as mentioned above, we direct the respondents 1 and 2 to take adequate action towards the removal of the encroachment, if any, pursuant to the representation of the petitioner dated 15.06.2020 and the communication dated 24.06.2020 within a period of eight weeks from the date of receipt of a copy of this order.

3. The writ petition stands disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.
