2.The learned counsel for the petitioner submitted that the petitioner was unable to mobilise the fund of Rs.30,000/-.

3. Heard both sides.

4. Considering the facts and circumstances of this case, this Court is not inclined to modify the condition imposed on the petitioner in Crl.O.P.No.10364 of 2020 dated 10.07.2020. Accordingly, this Criminal Original Petition is dismissed.

5.However, two weeks time is granted to the petitioner to deposit a sum of Rs.30,000/- (Thirty Thousand Only) as non refundable deposit to the Commissioner Corporation (For Amma Unavagam), from the date on which the order copy made ready. Failing which, the petition for anticipatory bail shall stand automatically dismissed.
