In view of the above development, there shall be a direction to the first respondent to proceed further with an enquiry strictly in accordance with law and pass orders within a period of six weeks from the date of receipt of a copy of this order. The first respondent shall give an opportunity to the third respondent before proceeding further with the enquiry and passing final order.
