O R D E R

Learned Additional Public Prosecutor submitted that even according to the petitioner, she borrowed a huge sum from the respondents 3 to 13 and she failed to repay the said amount and therefore, the victims have lodged complaint before the second respondent herein and after conducting enquiry the victims were directed to approach District Crime Branch on the ground that the money involved is huge.

3. Under these circumstances, now the petitioner has come forward with this petition seeking police protection from the respondents 3 to 13 herein. .When there is complaint as against the petitioner, that too having very serious nature of allegations, the petitioner cannot sought for any police protection.

4. This petition is devoid of merits and accordingly, dismissed.
