Mr.K.Pandiyan, the Assistant Jailer of the Sub-Jail, Ariyalur, had submitted that this was the first order in which they have been directed to release the accused on own bond and as an abundant caution the Jail Authorities have approached the learned Principal Judge Court and after getting clearance from the Court they have released the accused immediately and he submitted that the Jail Authorities have no intention to disobey the order of this Court.

3.In view of the submissions so made by the learned Government Advocate (Crl. Side) this petition stands clarified.
