Prayer: Writ Petition filed under Article 226 of the Constitution of India for issuance of a Writ of Mandamus, to forbear the respondents to proceed with tender process without permitting the petitioner to participate in the bid process which is scheduled to be held on 07.08.2020 pursuant to the tender notification issued by the second respondent bearing Tender No.MAT/OT/010/2020, dated 26.05.2020 due on 01.07.2020 and subsequently extended to 31.07.2020 by the second respondent vide Lr.No.CMWSSB/MAT/PUR/OT-010-2020/Spl/2020, dated 24.07.2020 and further extended to 07.08.2020.

ORDER
