Prayer: Writ Petition filed under Article 226 of the Constitution of India for issuance of a Writ of Certiorarified Mandamus, calling for the records leading to the issuance of the impugned High Tension Bills (Provisional) by the 2nd Respondent for April 2020 (Bill No. 9094350032052001 dated 06.05.2020) for May 2020 (Bill No. 9094350032062001 dated 05.06.2020) and for June 2020 (Bill No. 9094350032072002 dated 07.07.2020) pertaining to High Tension Service No.039094350032 in violation Regulation 6(b) of the Tamil Nadu Electricity Supply Code, 2004 and quash the same and direct the respondents to raise the monthly Bill calculating the Maximum Demand Charges at the rate of 20% as per 6(b) of the Tamil Nadu Electricity Supply Code, 2004 till the extend period of Lock Down, by the Government of Tamil Nadu and not to levy Power Factor penalty till the Lock Down is lifted and operation of Cinema theatres commences insofar the petitioner is concerned.
