The Inspector of Police, W8-All Women Police Station, Thirumangalam, Chennai has also sent a report dated 10.09.2020 stating that both the petitioner and his wife are living together at No.37, Pudhukollati, Nandhiyambakkam, Chennai - 120.

3.Though the learned Counsel for the Petitioner is not present, taking into consideration of the above representation and report, this Habeas Corpus Petition is closed.
