Writ Petition is filed under Article 226 of Constitution of India, seeking for a Writ of Certiorarified Mandamus, calling for the records leading to the issuance of the impugned High Tension Bills (Provisional) by the 4th respondent for the month of March 2020 (Bill No.9094111008032001 dated 03.03.2020), for

the month of April 2020 (Bill No.9094111008042002 dated 09.04.2020), for May 2020 (Bill No.9094111008052001 dated 11.05.2020), for June 2020 (Bill No.9094111008062002 dated 09.06.2020) and for July 2020 (Bill No.9094111008072001 dated 10.07.2020) pertaining to Service No.0990994111008, in violation of Regulation 6(b) of the Tamil Nadu Electricity Supply Code, 2004, and quash the same and direct the respondents to raise the monthly Bill calculating the Maximum Demand Charges at the rate of 20% as per 6 (b) of the Tamil Nadu Electricity Supply Code, 2004, from 17.03.2020, the date of lock down till the extended period of Lock Down by the Government of Tamil Nadu and not to levy power factor penalty till the Lock Down is lifted and operation of Cinema theatre commences in so far the petitioner is concerned.

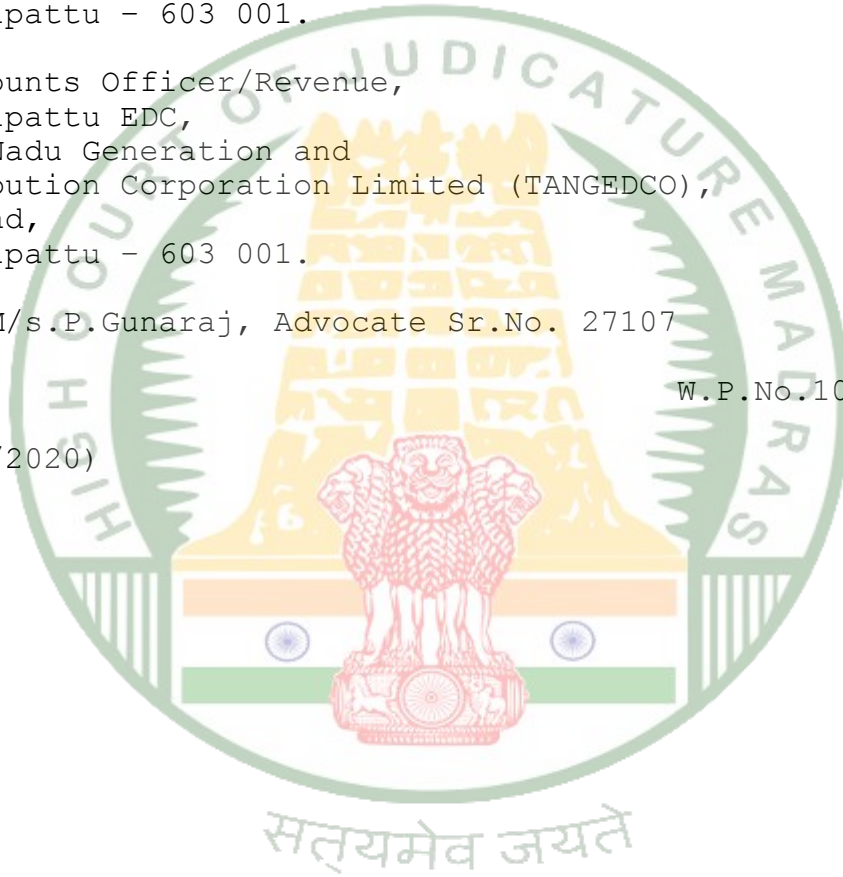
