The learned Additional Public Prosecutor would submit that two petitions enquiry against the petitioner is pending in C.No.28/DCB/DSP/TPT/202 on the complaint of one Tirupathy and C.No.27/DCB/DSP/TPT/202, on the complaint of one Viswanathan.

2 The respondent police has to issue notice under Section 41 (A) of Cr.P.C to the petitioner. The petitioner is directed to appear before the respondent police and the Investigating Officer has to conduct the enquiry by strictly following the procedures therein. The Investigating Officer is to either register a First Information Report or close the complaint by 16.09.2020 if the Investigating Officer has the grounds to arrest the petitioner, then he has to state the reasons in writing and communicate the same to the petitioner and in that case, the petitioner is at liberty to file necessary application before this Court seeking anticipatory bail.

3 With this observation, this Criminal Original Petition is closed.
