ORDER

(The case has been heard through video conference)

The petitioners, who were arrested and remanded to judicial custody on 27.07.2020 for the offences punishable under Section 341, 294(b), 324, 307, 506(ii) IPC. in Crime No.4943 of 2020, seek bail.

2.The case of the prosecution is that the petitioners have threatened the defacto complainant and assaulted him with knife causing injuries.

3.The learned Government Advocate (Crl. Side) would submit that the petitioners are history sheeters and rowdy elements. They have threatened the defacto complainant and attacked him with knife and caused injuries. He would further submit the petitioners have two previous cases and their arrest is very recent i.e. on 27.07.2020. Hence, he vehemently opposes for the grant of bail to the petitioners.

4.Taking into consideration of the fact that the petitioners were arrested only recently on 27.07.2020 and also considering the fact that they have two previous cases to their credit and they are history sheeters, this Court is not inclined to grant bail to the petitioners.

5.This Criminal Original Petition stands dismissed accordingly.
