Writ Petition under Article 226 of the Constitution of India praying for the issuance of a Writ of Certiorarified Mandamus to call for the records in High Tension Bill No. 9094350384042002 dt 8/04/2020 High Tension Bill NO. 9094350384052001 dt 07/05/2020 High Tension Bill No. 9094350384062001 dt 6/06/2020 and High Tension Bill No. 9094350384072001 dt 6/07/2020 and High Tension Bill No. 9094350384082002 dt 7/08/2020 for HT for the connection No. 039094350384 issued by the 2nd respondent and all further penal or interest charge Pursuant thereto (impugned Proceedings) and quash the same in so far it relates to Item 8 thereof i.e demand charges and consequentially direct the Respondents to issue bills for minimum demand charges at 20 Percentage of the sanctioned demand strictly in compliance with regulation 6 (b) of the Tamil Nadu Electricity Supply Code for the entire lockdown period and to refrain from levying or recovering any demand charges in excess of minimum demand charges under regulation 6(b) of the Tamil Nadu Electricity Supply Code 2004 for any part of the lockdown period and to refund any amounts collected or adjusted from the security deposit towards the excess / maximum demand charges for the lockdown period.
