Writ Petition is filed under Article 226 of Constitution of India, seeking for a Writ of Certiorarified Mandamus, calling for the records leading to the issuance of the original impugned High Tension Bills (Provisional) by the 2nd respondent for the month of April 2020 (Bill No.9094380481052001 dated 07.05.2020), May 2020 (Bill No.9094380481062001 dated 05.06.2020) and for the month of June 2020 (Bill No.9094380481072001 dated 06.07.2020) pertaining to Service No.039094380481 in violation of Regulation 6(b) of the Tamil Nadu Electricity Supply Code, 2004, and quash the same and direct the respondents to raise the monthly Bill calculating the Maximum Demand Charges at the rate of 20% as per 6 (b) of the Tamil Nadu Electricity Supply Code, 2004, till the extended period of Lock Down by the Government of Tamil Nadu and not to levy power factor penalty till the Lock Down is lifted and

operation of Cinema theatre commences in so far the petitioner is concerned.

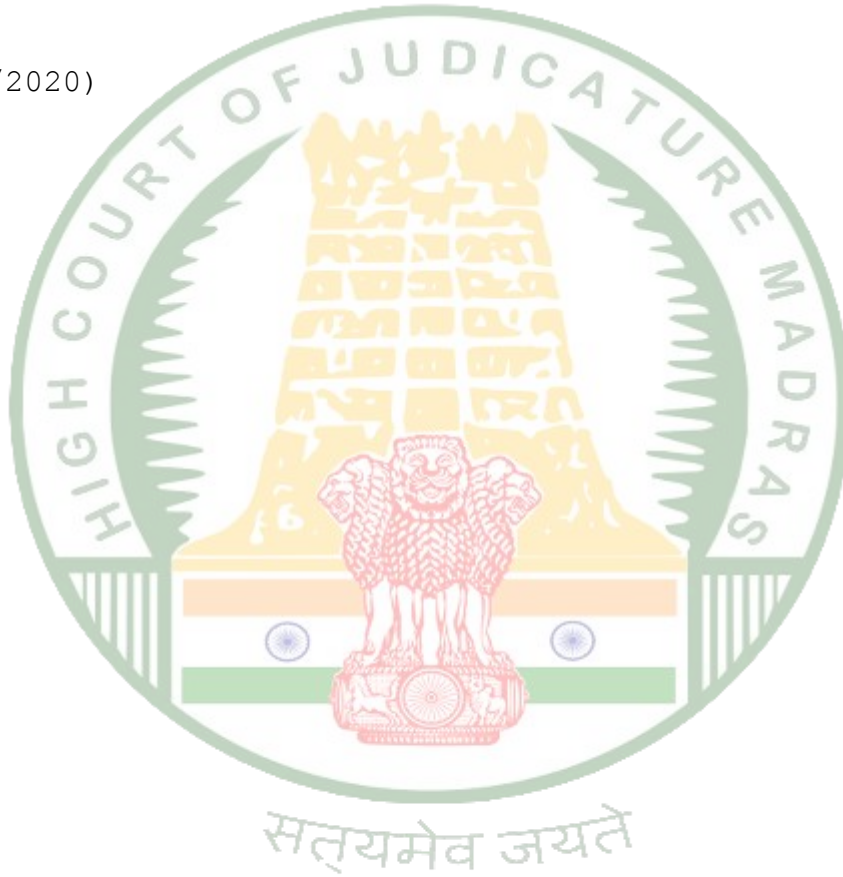
