Writ Petition is filed under Article 226 of Constitution of India, seeking for a Writ of Certiorarified Mandamus, calling for the records of the third respondent herein in Bill Nos.9094041908042001 dated 03.04.2020, 9094041908052001 dated 02.05.2020, 9094041908062003 dated 06.06.2020, 9094041908072003 dated 04.07.2020, and 9094041908082002 dated 03.08.2020 and quash the same and consequently direct the respondents herein to issue fresh bills for the period of lock down in terms of Regulation 6 (b) of the TN Electricity Supply Code and adjust the excess sums paid on 06.04.2020, 14.05.2020, 12.06.2020, 10.07.2020 and 10.08.2020 with future bills and further forbear the respondents herein from levying and collecting any sums in excess of Minimum Charges with respect to petitioner's Service Connection No. 019094041908 until the lock down is lifted.
