4. In view of the above submission, the condition imposed as against the petitioner in Crl.O.P.No.8172 of 2020 on 01.07.2020 is modified to the effect that the petitioner shall report before the respondent police on the first working day of every Month, at 10.30 a.m., until further orders.

5. With the above directions, this Criminal Original Petition is ordered.
