3. The learned Additional Public Prosecutor submitted that the petitioner has been complied the condition regularly from 15.07.2020.

4. Considering the submissions made by the counsel for the petitioners and the facts and circumstances of the case, the condition imposed in Crl.O.P.No.9846 of 2020 dated 13.07.2020 is modified to the effect that the petitioner shall appear before the respondent police once in a month i.e. on first Monday of every month at 10.30 a.m. until further orders.

5. With the above directions, this criminal original petition is ordered.
