3 At this juncture, the learned counsel appearing for the petitioners seeks permission of this Court to withdraw this petition in respect of the third accused viz., Praveen.

4 In view of the submissions made by the learned counsels, Crl.O.P.No.13654 of 2020 stands dismissed as withdrawn in respect of the fourth petitioner viz., Praveen and closed in respect of A2/Aravindan, A4/Moorthy, A5/Vinoth, A6/Balasubramanium and Crl.O.P.No.13659/2020 stands closed.
