Mrs.M.Prabhavathi, learned Additional Public Prosecutor who takes notice on behalf of the respondents would submit that the petitioner's husband/detenu is involved in a kidnapping case which also relates to Hawala transaction. The petitioner's husband is a history sheeter and he has been arrested in Crime No. 956 of 2020 dated 22.08.2020 under Sections 419, 364 (a), 324, 342, 464, 465, 468, 392 r/w 395 of I.P.C.

4. Since the petitioner's husband has been legally arrested, invoking certain provisions of I.P.C. along with other accused, this Petition is closed.

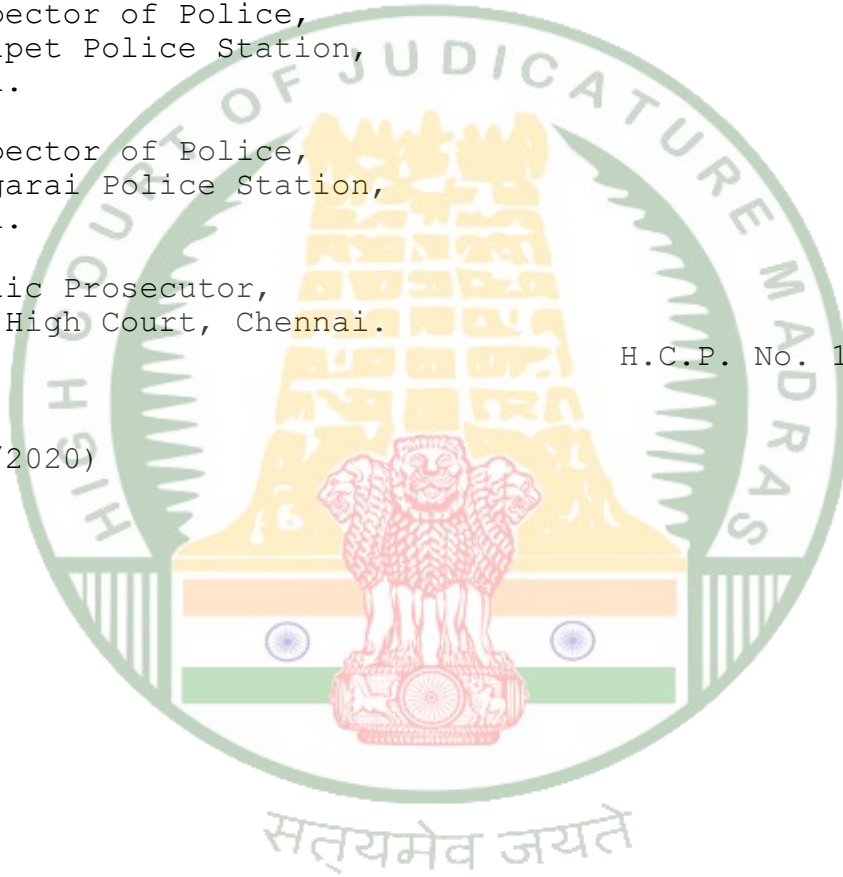
