ORDER : The Court Made the following order :-

This Court, by an Order dated 10.09.2020, had directed the learned II Additional Special Judge, II Additional Special Court, under NPDS Act, Chennai to dispose the case in C.C.No.74 of 2020, within a period of six months from the date of resumption of normal functioning of Courts.
