Hence, he prays to modify the said condition.

3. The learned Additional Public Prosecutor (Puducherry) submitted that the present petition for modification has been filed without approaching the Court concerned as ordered and the investigation is still pending.

4. In view of the submission made by the learned Additional Public Prosecutor, this Criminal Original Petition is dismissed. However, liberty is granted to the petitioner to approach the concerned Court.
