3. The learned would submit that petition enquiry against the petitioners are pending in C.S.R.No.75 of 2020 on the complaint of one Ashwini.

4. The respondent police has to issue notice under Section 41(A) of Cr.P.C., to the petitioners. The petitioners are directed to appear before the respondent police and the

Investigating Officer has to conduct the enquiry by strictly following ocedures therein. The Investigating Officer is to either register a First Information Report or close the complaint by **12.10.2020**. If the Investigating Officer has grounds to arrest the petitioners, then he has to state the reasons in writing and communicate the same to the petitioners and in that case, the petitioners are at liberty to file necessary application before this Court seeking anticipatory bail.

5. With this observations, this Criminal Original Petition is closed.
