These petitions have been filed to relax the condition passed by this Court on 06.03.2020 in CrI.O.P.No.5360 of 2020 that the petitioner shall report before the respondent police for one week from the date of enlarge on Anticipatory Bail and to extend the time stipulated for executing the surities resepctively.
