3. Recording the submission made by the learned counsel for the applicant, this application is closed and the appellant shall work out his remedy before the Execution Court.

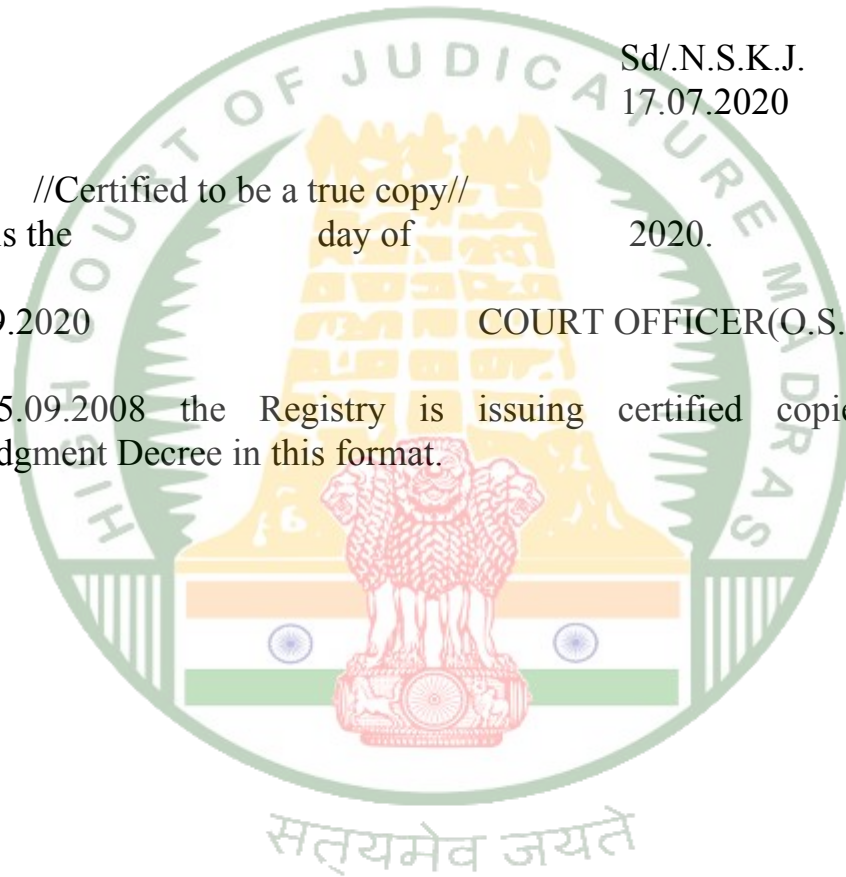
