Prayer: Writ Petition filed under Article 226 of the Constitution of India for issuance of a Writ of Certiorarified Mandamus, to call for the records leading to the issuance of the original impugned high tension bills(provisional) issued by the second respondent for the month of March 2020, dated 08.04.2020, April 2020 dated 06.05.2020, May 2020 dated 04.06.2020, June 2020 dated 06.07.2020 and July 2020, dated 12.08.2020, August 2020 dated 07.09.2020 pertaining to service No.099094010904 in violation regulation 6(b) of the Tamil Nadu Electricity Supply Code, 2004 and quash the same and direct the respondents to rework the HT Bill with service number 099094010904 and the excess amount shall be adjusted towards the future bills and the minimum charges alone shall be collected by the second respondent for the period from March 2020 to August 2020 and not to levy any penalty for the period of lock down.
