Taking into consideration, the facts and circumstances of the case and also of the fact that the third respondent has already fixed the date for enquiry and called the parties for enquiry, there shall be a direction to the third respondent to conduct the enquiry after giving opportunity to the petitioner and the fifth respondent and pass orders strictly in accordance with law, within a period of six weeks from the date of receipt of a copy of this order.

4. This writ petition is disposed of with the above directions. No costs.
