3.Heard the parties and perused the materials on record. It is seen from the records that a certificate issued by the Hospital dated 08.08.2020 has been filed before this Court. It is evident from the report of the probation officer that the convict came out only in the month of March 2020 and availed 21 days leave. Moreover, the convict's mother is only taking treatment as out-patient and it is evident from the Officer's report and she is being taken care by her relatives.

4.In view of the above, this Habeas Corpus Petition is dismissed.
