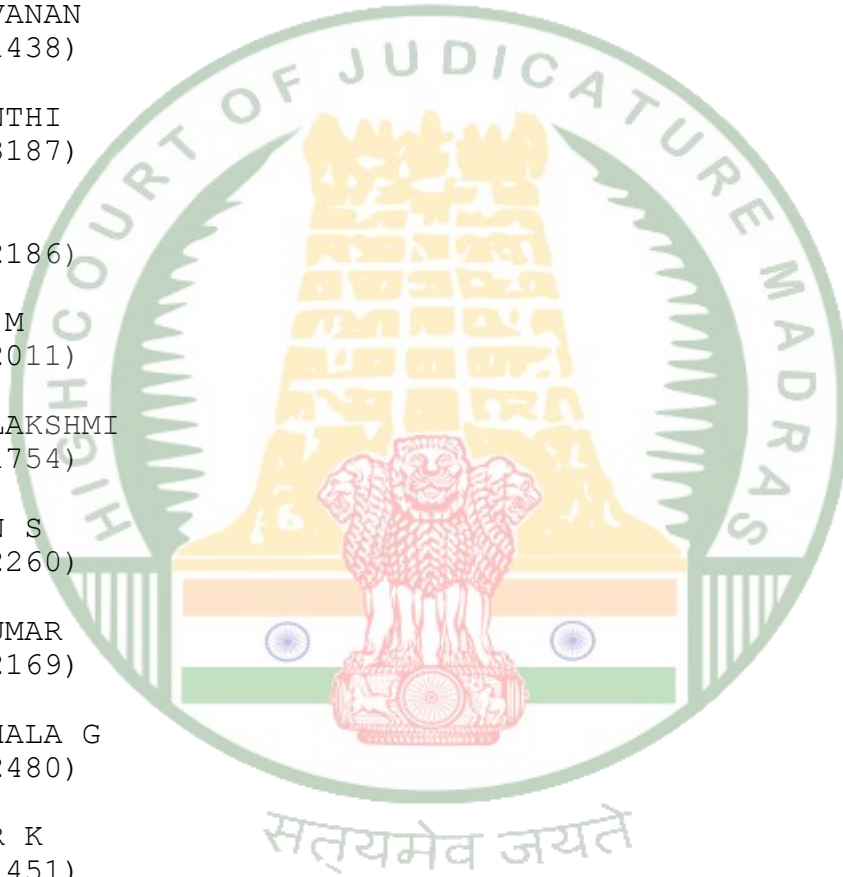

Since the writ petitioner has challenged the selection list to the post of Junior Inspector of Sericulture in the writ petition, the relief sought for by the petitioner in the present Miscellaneous Petition cannot be considered at this stage and the same shall be decided at the time of final disposal of the main writ petition.

In view of the above, the Miscellaneous Petition is dismissed.
