In the meanwhile, the Revenue Divisional Officer, Thiruchengode, in his proceedings in Pa.Mu.No.1695/2020/T, dated 28.10.2020, had directed the Registrar of Birth and Deaths (Vellur Town Panchayat) to issue the Death Certificate to the petitioner.

4. The learned counsel for the petitioner also states that the Death Certificate itself was issued to the petitioner yesterday (i.e) 23.11.2020.
