2.Heard both sides.

3.The learned Government Advocate Criminal Side Mr.G.Ramar stated that there are 65 prosecution witnesses and the trial has not yet commenced.

4.In view of that, the earlier order dated 05.11.2020 is maintained and considering the submission, the condition imposed as against the petitioner is modified to the effect that the petitioner herein may appear before the Additional District Court, Namakkal once in every alternate Mondays at 10.30 a.m. and also appear during every hearing date before the trial. If the petitioner defaults complying with the conditions on two consecutive Mondays as stated then the prosecution is at liberty to seek modification of this particular
