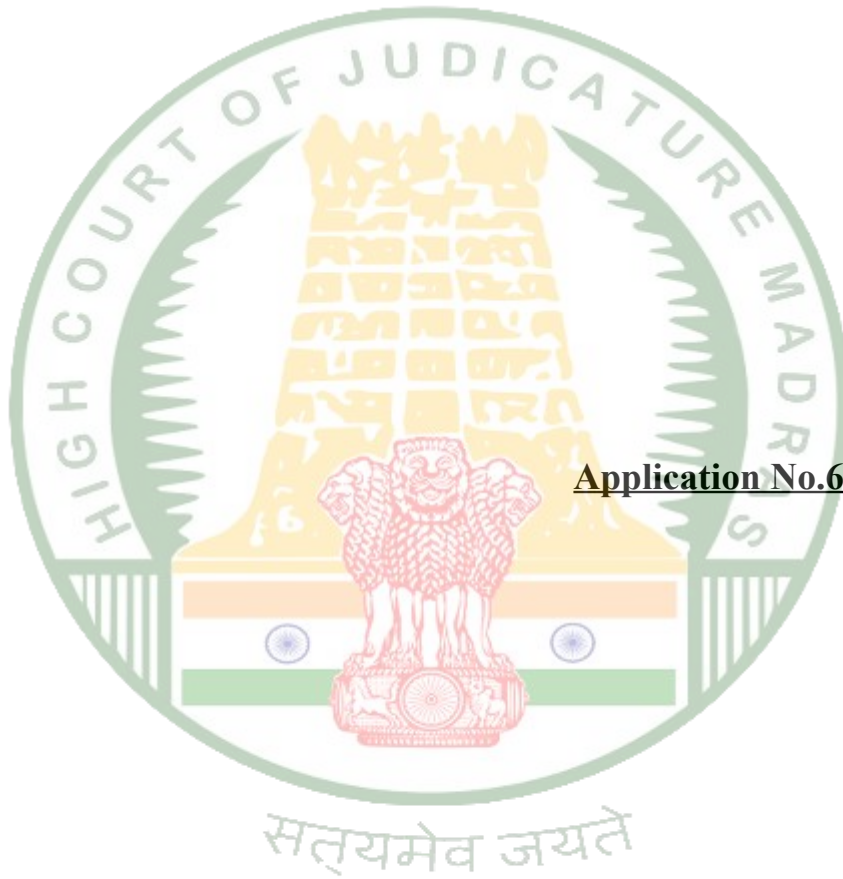
The learned counsel appearing for the applicant seeks to withdraw this application and he has sent an endorsement through e-mail to that effect.
