O R D E R

This Writ Petition has been filed for the issue of writ of Mandamus directing the respondent to act upon the application submitted by the petitioner, wherein, the petitioner has sought for the survey of the subject property for the purpose of fixing the boundary.

3. The learned Govt. Advocate, on instructions submitted that the respondent has fixed the date for survey on 22.10.2020 @ 10 a.m. The learned counsel submitted that the petitioner can also be present at the time of survey along with all relevant

documents and the same will be completed within the time fixed by this Court.

4. Taking into consideration the facts and circumstances of the case and also of the fact that the respondent has already fixed the date for survey, there shall be a direction to the respondent to complete the survey within a period of four weeks from the date of receipt of a copy of this order.

5. This Writ Petition is disposed of with the above direction. No costs. Consequently, the connected miscellaneous petition is also closed.
