O R D E R

3.Taking into consideration the facts and circumstances of the case and also of the fact that the third respondent has already called the parties for an enquiry, there shall be a direction to the third respondent to afford sufficient opportunity to the petitioner as well as the fifth respondent and pass final orders, strictly in accordance with law within a period of six weeks from the date of receipt of copy of this order.
