ORDER

Mr.Mani Gopi, learned Government Advocate appearing on behalf of the respondents submitted that the 3rd respondent has already fixed a date for enquiry on 06.11.2020 at 10.00 a.m. The learned counsel submitted that the petitioner can be present at the time of enquiry along with all the relevant documents.

3.Taking into consideration the facts and circumstances of the case and also of the fact that the 3rd respondent has already called the petitioner for an enquiry, there shall be a direction to the 3rd respondent to complete the process strictly in accordance with law, within a period of six weeks from the date of receipt of copy of this order.

4.This writ petition is disposed of with the above directions. No costs. Consequently, connected miscellaneous petition is closed.

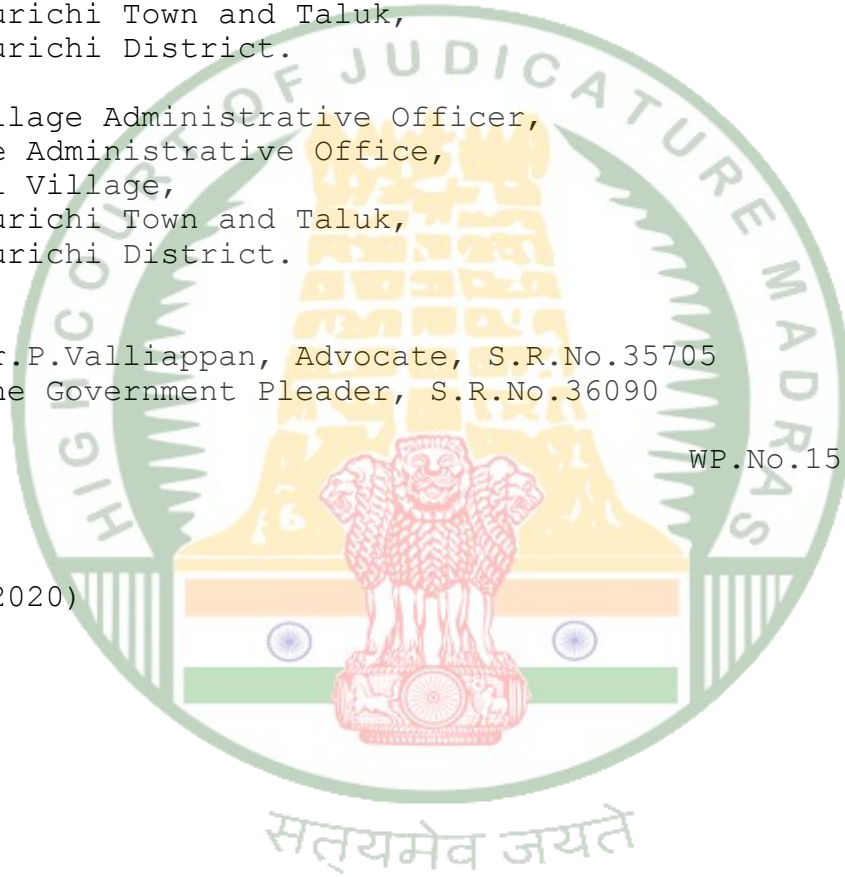
