Prayer:- Writ petition filed under Article 226 of the Constitution of India praying for issuance of a writ of Mandamus directing the respondents herein to raise revised bills viz., (1) Bill No.9094041448042002 dated 03.04.2020, (2) Bill No.9094041448052002 dt.02.05.2020, (3) Bill No.9094041448062002, dt.01.06.2020, (4) Bill No.98094041448072002 dt.03.07.2020, (5) Bill No.9094041448082002 dt.03.08.2020, (6) Bill No.9094041448092003 dt.02.09.2020 and (7) Bill No.9094041448102002 dt.02.10.2020 calculating minimum charges at

the rate of 20% of the contracted demand or recorded demand whichever is higher as Regulation 6(b) of the TN Electricity Supply Code 2004 without compensation on low PF penal charges, belated payment charges and interest, adjusting excess amount on paid-bills towards future bills till the extended period of lockdown.

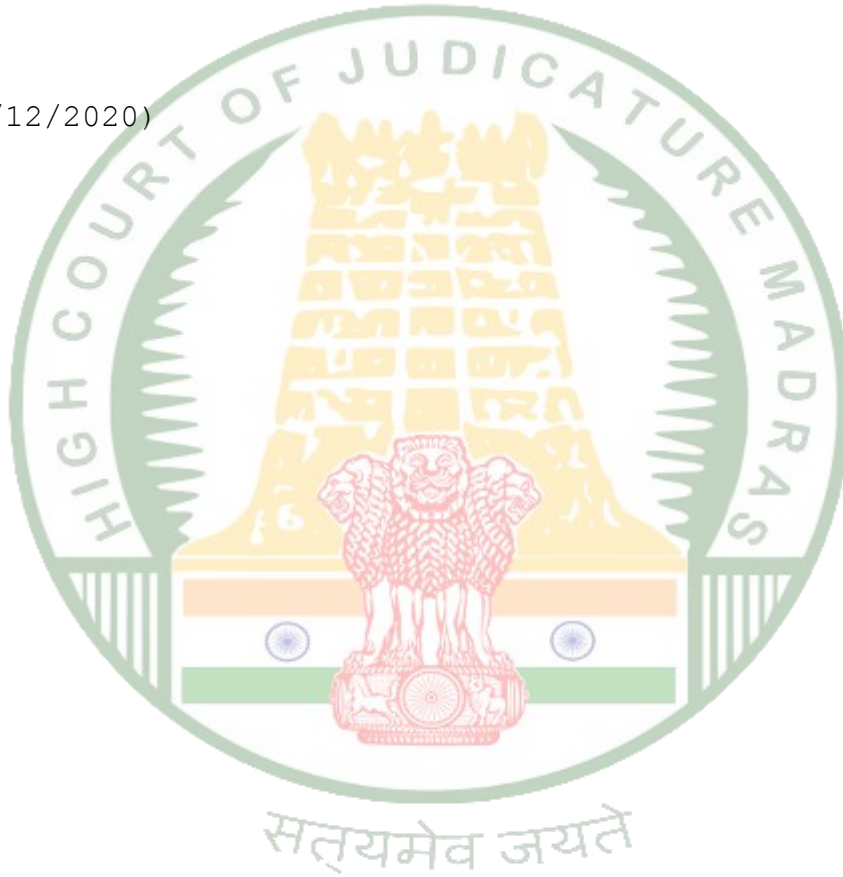
