ORDER

The learned counsel submitted that the petitioner can be present along with all the relevant documents and the 1<sup>st</sup> respondent will take a decision with regard to conduct of survey in the subject property.

3.Taking into consideration the facts and circumstances of the case and also of the fact that the 1st respondent has called the petitioner for preliminary enquiry, there shall be a direction to the 1st respondent to conduct the preliminary enquiry after affording opportunity to the petitioner and shall take a decision strictly in accordance with law, within a period of four weeks from the date of receipt of a copy of this order.

This Writ Petition is disposed of with the above directions. No costs.
