ORDER

This matter is taken up for hearing through Video-Conferencing mode.

2.It is the case of the petitioner that his pigs were seized by the respondents on 06.10.2020. In this Connection, the petitioner has sent representation dated 07.10.2020 and

19.10.2020. However, no orders have been passed by the respondent so far.

3. The learned counsel for the petitioner would submit that these animals are at the risk if they are not taken care properly. Considering the same, the respondents are directed to pass appropriate orders on or before 29.10.2020. The petitioner is directed to be present before concerned officer on 28.10.2020. The 1<sup>st</sup> respondent shall hear the petition before any orders are passed.

4. The petitioner is further directed to positively appear before the 1<sup>st</sup> respondent on 28.10.2020 at 2.30 p.m., the 1<sup>st</sup> competent respondent shall pass appropriate order on or before 29.10.2020 in accordance with law.

5. With the above direction, this Writ Petition is disposed of. No costs. Consequently, connected writ miscellaneous petition is closed.
