2.The learned counsel for the petitioner would submit that earlier, the petitioner has been granted bail by this Court in Crl.Op.No.3632 of 2020, on 05.03.2020 with condition to surrender and execute the sureties before the concerned Magistrate within 15 days. He would further submit that the petitioner was unable to surrender and execute the sureties within 15 days, and thereby, the earlier order had got lapsed and hence, he prays to extend the time to execute the sureties.
