2. The learned counsel for the petitioner submitted that this Court granted bail to the petitioner in Crl.O.P.No.7433 of 2020 dated 13.07.2020 with a condition to execute two sureties. He has further submitted that since the petitioner was arrested in yet another case in Crime No.675 of 2020, on the file of Erode South Police Station, he was not able to execute two sureties for a sum of Rs.10,000/-.
