ORDER

2. It is brought to the notice of this Court that the respondents have already disconnected electricity. In view of the orders passed in this Writ Petition, the 3rd respondent is directed to restore electricity connection immediately on payment of the revised current consumption bills and dues towards energy charges, if any.

3. Accordingly, this writ petition is allowed. No costs. Consequently, connected miscellaneous petition is closed.

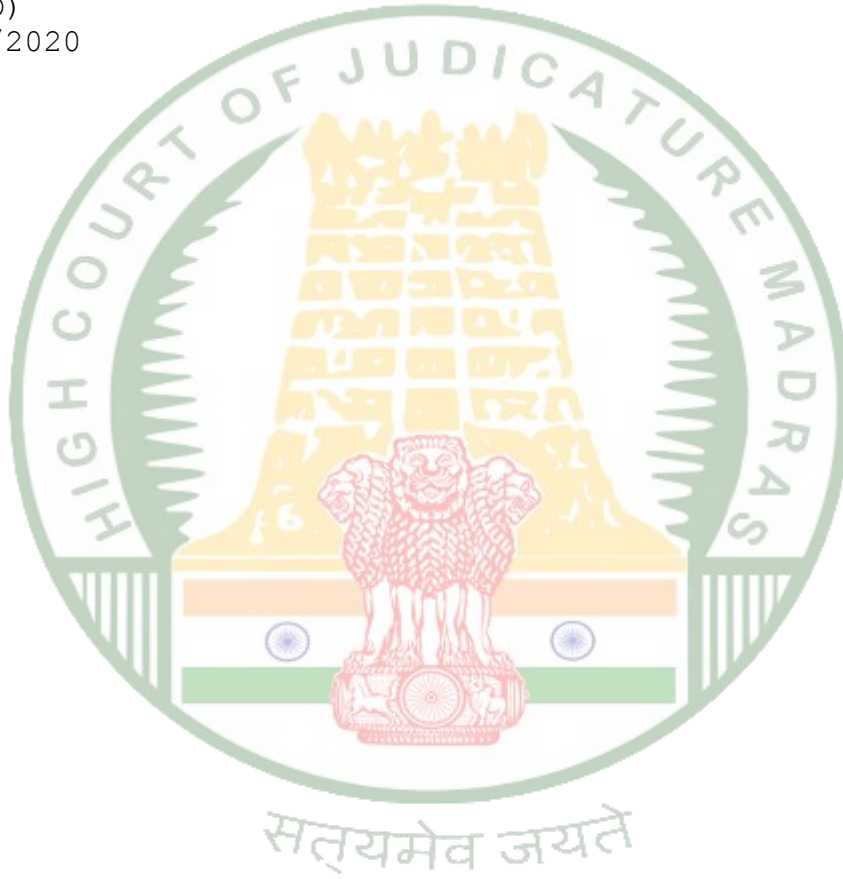
