There shall be no order as to costs. Consequently, the connected Miscellaneous Petitions are closed.

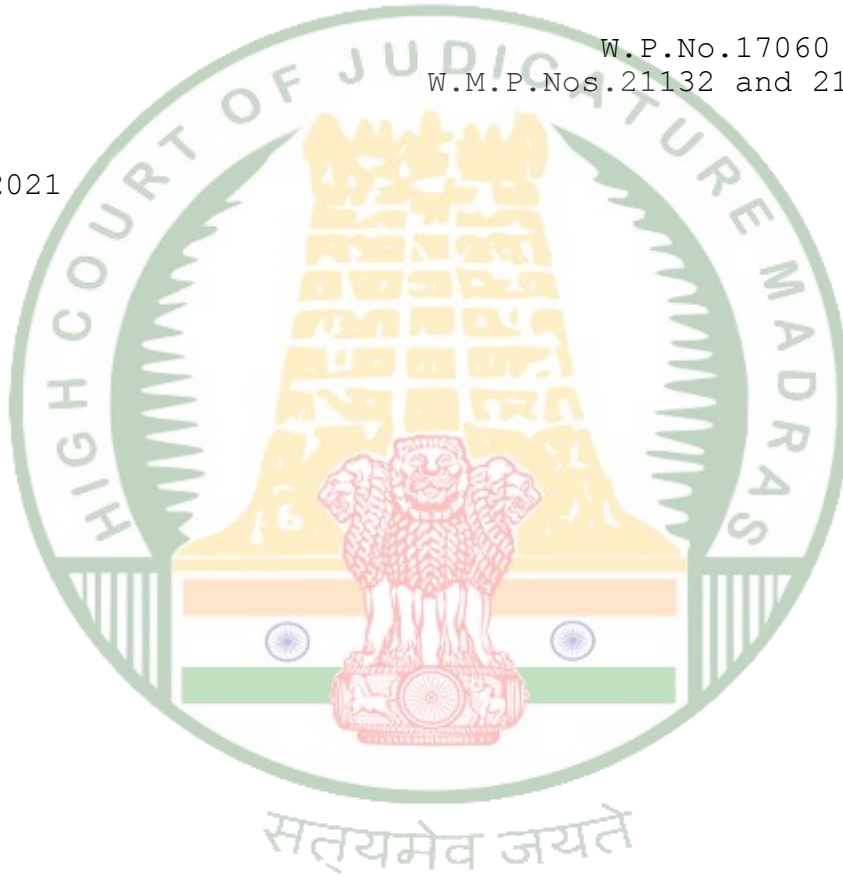
