JUDGMENT

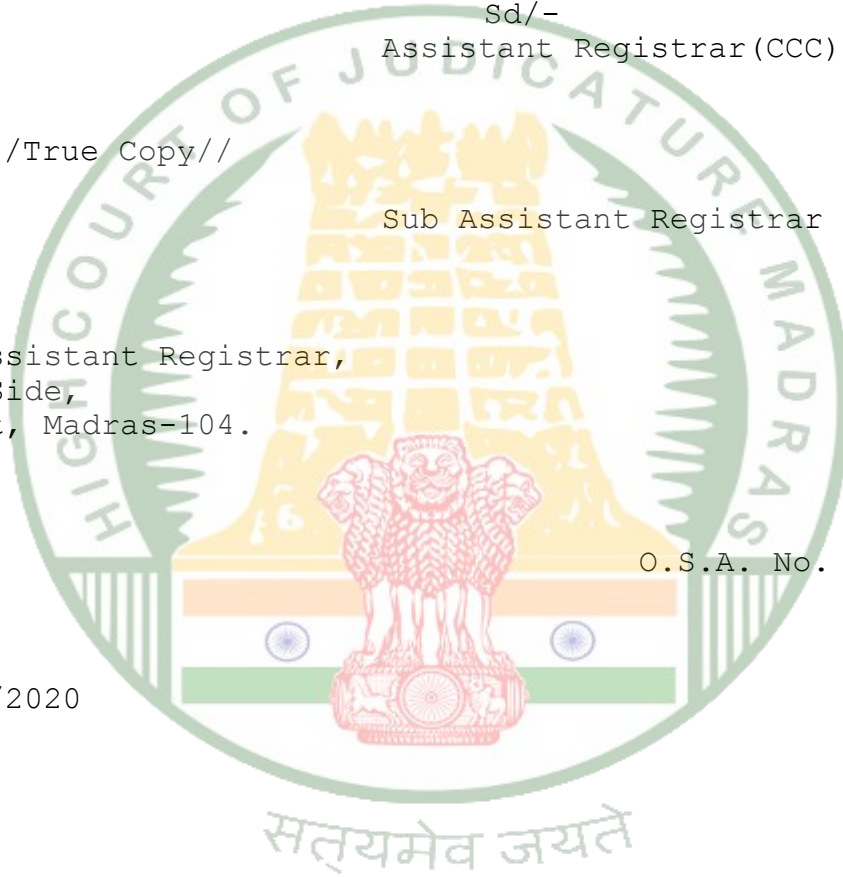
