O R D E R

This Writ Petition has been filed for the issue of Writ of Mandamus directing the 3<sup>rd</sup> respondent to consider the application submitted by the petitioner on 10.07.2019 and conduct the survey of the subject property and grant individual patta in the name of the petitioner.

2. Mr. S.N.Parthasarathy, learned Govt. Advocate appearing on behalf of the respondents 1 to 3 submitted that the 3<sup>rd</sup> respondent has called the parties for an enquiry on 5.1.2021 at 3 p.m. The learned counsel for the petitioner submitted that the petitioner can be present at the time of enquiry along with all the relevant documents.

3. Taking into consideration the facts and circumstances of the case and also of the fact that the 3<sup>rd</sup> respondent has already called the parties for an enquiry, there shall be a direction to the 3<sup>rd</sup> respondent to conduct the enquiry after affording an opportunity to the petitioner and one Mrs.Vijayakumari and final orders shall be passed strictly in accordance with law within a period of six weeks from the date of receipt of a copy of this order.

4. This Writ Petition is disposed of with the above directions. No costs.
