The learned counsel submitted that the petitioners can be present at the time of enquiry along with all the relevant documents.

3.Taking into the consideration the facts and circumstances of the case and also of the fact that the 2nd respondent has already called the petitioners for an enquiry, there shall be a direction to the 2nd respondent to conduct the enquiry and pass necessary orders strictly in accordance with law, within a period of six weeks from the date of receipt of a copy of this order.

4.These Writ Petitions are disposed of with the above directions. No costs.

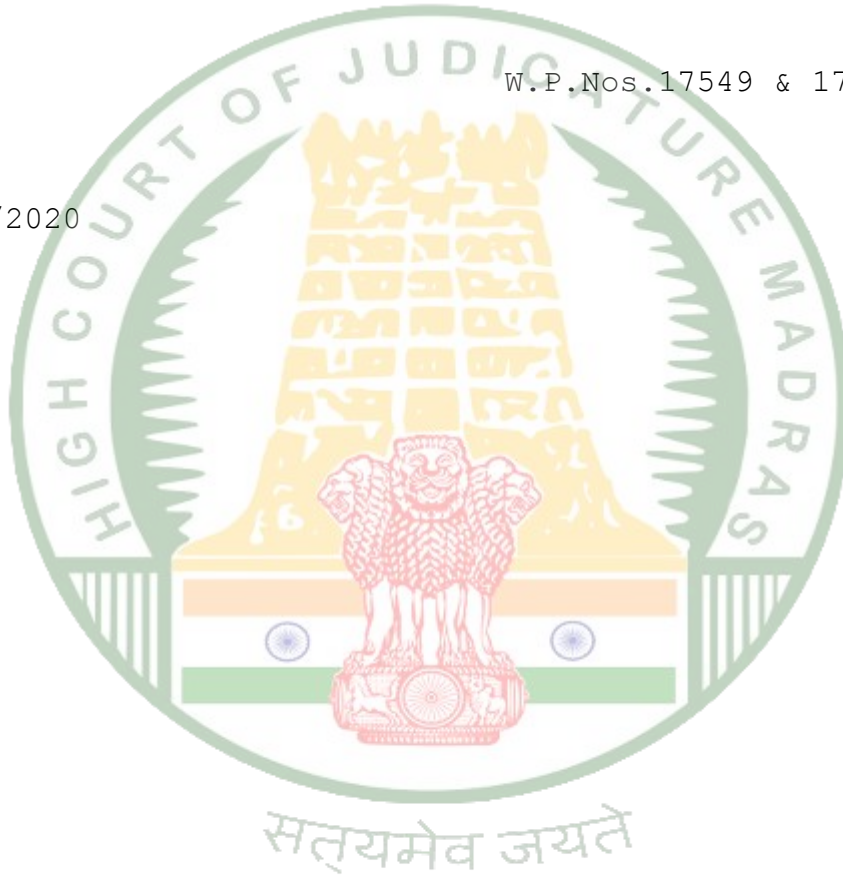
