3.Taking into consideration the facts and circumstances of the case and also of the fact that the 4rd respondent has already called the petitioners for enquiry, there shall be a direction to the 4th respondent to take a decision strictly in accordance with law, within a period of four weeks from the date of receipt of copy of this order.
