ORDER

3.Taking into consideration the facts and circumstances of the case and also of the fact that the 3rd respondent has already called the parties for an enquiry, there shall be a direction to the 3rd respondent to conduct an enquiry after affording opportunity to the petitioner and other necessary and interested parties and the 3rd respondent shall pass final orders strictly in accordance with law, within a period of six weeks from the date of receipt of a copy of this order.
